0. Abstract

To improve the license mechanism of AR G3 series routers and meet the requirements for on-demand service delivery, a new license framework is set up starting from V2R2. The new license framework will replace the original feature license framework. In addition, the original licenses cannot be purchased any more, but they can still be used independently from the new license framework.

6. Change Reason

To improve the license mechanism of AR G3 series routers and meet the requirements for on-demand service delivery, a new license framework is set up starting from the general availability (GA) of V2R2. The new license framework will replace the original feature license framework.

7. Change Description

7.1 New Licenses

The new licenses that have gone to the market include licenses of basic data packages, data value-added service (VAS) packages, voice VAS packages, and security VAS packages. The basic data packages are free of charge, and installed and activated by default. The data VAS packages and security VAS packages contain some new data and security value features added to V2R2. More data and security features will be added to later versions. The voice VAS packages contain the AG function that is free of charge in V2R1.



7.2 License Structure Change

The original flattened license structure is changed to a hierarchical license structure. That is, the new licenses depend on each other. For example, the PBX license can be purchased independently before. However, you must purchase the voice VAS packages first, and then new CM or BEST, CT, and IVR licenses (the three licenses can be purchased independently).

7.3 Original PBX License Change

The PBX license is replaced by CM or BEST, CT, and IVR licenses. In addition, the new license depends on the




voice VAS packages, and IVR depends on the CM or BEST license.

8. Impact

- (1) Before July 31, 2012, users who have already purchased the PBX license can continue using services defined by the PBX license in V2R1, V2R2, and later versions.
- (2) After July 31, 2012, the PBX license cannot be purchased, and the new license will go to the market. If users need to purchase the original PBX license, they have to purchase new CM or BEST, CT, and IVR licenses that can be purchased independently. The software version of devices must be later than V2R2. If the original software version is V2R1, the new license can be used only after the software is upgraded to

V2R2 or a later version.

(3) If a device uses V2R1 and the voice AG function, the AG function can still be used and the AG license does not need to be purchased after the software is upgraded to V2R2 or a later version.

AR IVR License	 The function of IVR queuing and automatic connection is similar to that of a console. When an external user dials the access code of an IVR service, the system asks the subscriber to dial the extension number or the exchange number. That is, the subscriber can directly dial the extension number to enter the conversion or dial the exchange number to trigger the simultaneous ringing service, sequential ringing service, or line selection service (selecting a subscriber based on certain rules). When multiple subscribers call the IVR switchboard, subsequent subscribers wait in the call queue and hear the call queue announcement. DISA service can be considered as an IVR application and needs an IVR license.
